## MEMORANDUM OF UNDERSTANDING

### **ANNAI HAJIRA WOMEN'S COLLEGE**

Annai Hajira College Road, Melapalayam, Tirunelveli 627 005, Tamil Nadu

&

### **MUSLIM ARTS COLLEGE**

Thiruvithancode, Kanyakumari District 629 174 Tamil Nadu

Annai Hajira Women's College, Melapalayam, Tirunelveli -627005, Tamil Nadu and Muslim Arts College, Thiruvithancode, Kanyakumari District 629 174, Tamil Nadu agree to collaborate with each other subject to mutual consent.

The areas of collaboration will include any programme offered at either institution as thought desirable and feasible on either side and that both sides will contribute to fostering and development of the collaborative relationship between the two colleges. Collaboration shall be carried out through such activities as:

1. Exchange of faculty
2. Exchange of students
3. Joint research activities a research article publication
4. Participation in seminars and academic meetings
5. Exchange of academic materials and other information
6. Special short term academic programs

The terms of cooperation for each specific activity implemented under this MoU for Cooperation shall be mutually discussed and agreed upon in writing by both colleges prior to the initiation of that activity. Any Such MoUs entered into, as outlined above, will form appendices to the MoU for Cooperation.

The two colleges hereby agree on the following articles to establish the Exchange Program.

### **1. STUDENT EXCHANGE**

1. The aim of the exchange program is to provide students as opportunity to have experience of a very old and world reputed institutional cooperation and exchange, as well as to gain a better understanding of two different environments.

2. The term of study for exchange students participating in this program shall be one week to one month, but may be extended with the consent of both institutes
3. The number of students exchanged under this MoU shall be not more than five students at each institute. The total number of mutual exchange students will be about same from each institute during the term of five year.
4. The host institute has the right to decide acceptance of exchange students, by taking account of recommendations issued from the home institute for exchange student based on their academic record.
5. The host institute will waive any application fee, entrance fee and tuition fee of the exchange students. The transportation, accommodations, food clothing and other personal costs including medical care will be the personal responsibilities of the students themselves. However, the host institute may charge an amount for providing laboratory; library internet facilities etc., and the amount will be intimated at the time of making an offer.
6. The host institute shall reserve or make available accommodation on campus for exchange students or assist them in locating suitable housing off campus if they so deserve.
7. The exchange student is treated as either the research student or specifically registered student /Final Year UG or PG student.
8. The exchange students will be subject to the student rules at the host institute, while on exchange. Exchange students will be offered the same facilities as local students.

9. Exchange students will study subjects or conduct research projects, which are pertinent to their field of study and are offered by the host institute.
10. The acceptance of the course work taken at the host institute and the measure of achievement attained there will be communicated to the home institute.
11. Any Intellectual Property developed during the joint activity will be jointly owned by the two institutes.

## **II. FACULTY EXCHANGE**

1. Two institutes will actively seek promote mutual faculty exchange for mutual agreed periods.
2. Faculty exchange may assume various forms, such as individual short-term and long-term visits of faculties, joint research and development projects.
3. Both institutes will try to seek external finding resources to facilitate these exchanges.
4. Encouragement of the academic facility to co-author publications, joint research activities and joint project possibilities is subject to applicable copyright and / or other rules and regulations of the perspective institutes.
5. The host institute will endeavour to, as much as possible; make available such facilities that will enable the faculty to obtain experience and training in its departments and institutes, including the uses of its laboratories and libraries.

6.The two institutes acknowledge that in the absence of an external funding agency, all expenses for travel, living and allied costs will be left to the discretion and the responsibility of the home institute.

7.All intellectual property developed during the joint activity will be jointly owned by the two institutes.

### **III.EXCHANGE OF INFORMATION**

Information will be actively exchanged, including information for students, information on research and study provided at the institute, relevant information about faculty members and fields of research, institute publications.

### **IV.TERMS OF IMPLEMENTATION, RENEWAL, REVISION, CANCELLATION AND NOTICES**

1. Details of the implementation of any particular exchange resulting from this MoU shall be negotiated between two institutes.
2. The MoU will become effective on the day it is signed and remains valid for five years.
3. This MoU will be renewed after five years upon the consent in writing of both institutes. Each institute may cancel the MoU by jointly notifying the other institute of the intent to do so at least six months in advance of its expiration. Projects in progress at the time of termination will remain unaffected.
4. Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not be binding unless reduced to writing and signed by both institutes.

## Memorandum Of Understanding

This Memorandum Of Understanding is made on 24/08/2016 at Chennai by and between

ICT Academy, acting by and through its Chief Executive Officer as the authorized officer of the ICT Academy, having their office at ELCOT Complex, 2-7, Developed Plots, Industrial Estate, Perungudi, Chennai - 600 096 (which expression shall unless repugnant to the context or meaning thereof, be deemed to include its successors and permitted assigns, nominee/s and or delegate/s) (hereinafter referred to as the "ICT Academy") on one part.

AND

Muslim Arts College started functioning at Madhavalayam in the year 1982. It was a long felt need of the Muslim Educational Society of Kanyakumari District to have a college giving equal opportunity and access to the Muslim minority. The college was affiliated to Madurai Kamaraj University and approved by the Government of Tamilnadu.

Later it was shifted to Jalal building, Thiruvithancode, and the college witnessed a steady growth. With the Establishment of Manonmaniam Sundaranar University, Tirunelveli the college got affiliated to the new University. The college has by now achieved excellence in higher education with more than 2000 students and 180 faculty members and 75 members of non teaching staff. A very significant breakthrough in the history of the college was the introduction of the new courses in 2000-2001.

Now the college has more than thirty four (UG & PG) courses and eight Research Departments.

### WITNESSETH:

ICT Academy is an initiative of the Government of India in collaboration with the state Governments and Industries. ICT Academy is a not-for-profit society, the first of its kind pioneer venture under the Public-Private-Partnership (PPP) model that endeavors to train the higher education teachers and students thereby exercises on developing the next generation teachers and industry ready students.

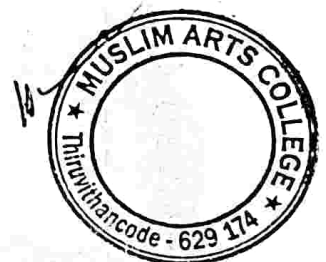
NOW THEREFORE it is mutually agreed by and between the Parties as under

### 1. ROLES & RESPONSIBILITIES

ICT ACADEMY, shall define the roles and responsibilities for the smooth implementation of the project from time to time based on mutually acceptable terms.

Any notice or other information required or authorized by this agreement to be given shall be given in writing, in English and by hand delivery with a written acknowledgement in receipt thereof or sending it by registered post with acknowledgement due, by courier with proof of delivery or sending it by facsimile transmission or e-mail communication.

### 5. PARTIAL INVALIDITY:

Any infirmity nor invalidity of any part of this agreement shall not ipso factum invalidate this agreement and this agreement is valid in other aspects and the invalidity can be substituted by suitable modification and or by new terms.

### 6. CONFIDENTIALITY:

This agreement and all written or electronic information (including oral discussions thereafter reduced to writing or otherwise recorded) in connection with the efforts contemplated in this agreement shall be treated as confidential, and may not be used by any party except in connection with the subject matter of this agreement, or disclosed to any other person (other than its affiliates, employees, consultants and advisors, who shall be bound to a similar degree of confidentiality, and limited to such extent that are required to perform their official functions) without the prior written consent of the other party. Confidential information shall not include information which now or hereafter enters the public domain through no violation of this clause. Neither party shall issue a press statement or disclose the contents hereof or matters related thereto to the press or any third party except with the express and prior written approval of the other.

### 7. NON-TRANSFERABILITY:

This agreement duly executed is not transferable in case of any merger/acquisition with or by other institutions.

### 8. AMENDMENT:

Any modification, amendment, or waiver of any provision of this agreement shall be effective if, but only if, in writing and signed in person or by an authorised representative of each party.

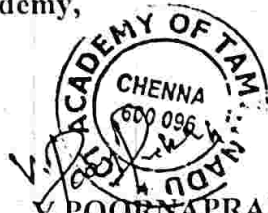

**To Promote Quality Assurance in Higher Education**

This Memorandum of Understanding (MoU) is effective as of 23.08.2019 to establish an affiliation by and between Sadakathullah Appa College, Tirunelveli, having been identified by NAAC as a Mentor Institution to offer mentoring services to non-accredited institutions in the geographic vicinity, referred to as SAC, of the FIRST PART

and

Muslim Arts College located at Thiruvithancode, an institution offering higher learning, referred to as MAC, of the SECOND PART for the purpose of Training of faculty and staff for proper processes, documentation, presentation, sharing of knowledge, information, research collaboration, resources and to adopt best practices.

**Preamble:**

Whereas, SAC and MAC have many shared interests in offering Quality Higher Education, considerable advantage and benefits may be gained from their collaborative pursuit in imparting Quality Higher Education.

**Article 1: Objectives**

Both the Institutes agree to develop the following collaborative activities in the academic areas of mutual interest on a basis of equality and reciprocity.

The two institutes shall seek to promote:

- i. Objectives set for improving the overall quality of the concerned institutions in conformance with "Paramarsh" an initiative for mentoring the non-accredited institutions.
- ii. The Scheme through a "Hub & Spoke" (H & S Model) where in the mentor institution called the "Hub" is centralized and will have the responsibility of guiding the Mentee institution through the secondary branches, the "spoke" which are the additional services provided to the mentee for self improvement which allows centralized control over operational efficiency and resource utilization to attain overall development for the mentee institution.

## **Article 2 : MENTEE BENEFITS**

- i. Brings about enhancement in the overall quality of the mentee institution.
- ii. Enhances the profile of the mentee institution as a result of improved quality of research, teaching and learning methodologies.
- iii. Receives support in the Professional Development of Academics.
- iv. Gets increased exposure and quickens adaption to the best practices.
- v. Advantage point in NAAC Accreditation and NIRF Ranking.

## **Article 3 : MENTOR BENEFITS**

- i. Additional learning acquired from experience.
- ii. Intellectual challenge of working in different environment.
- iii. Opportunities for increased collaboration.
- iv. Satisfaction of helping other institutions and see them succeed.

## **Article 4 : SALIENT FEATURES**

- The mentor institution should identify the potential areas of improvement in assessment criteria for accreditation in individual mentee institutions *eg.* Curricular Aspects, Teaching, Learning & Evaluation, Research, Innovations & Extension, Institutional Values & Best Practices *etc.* Further, the mentor institution can guide the mentee institution to focus and guide their application procedure at different stages.
- Mentoring shall be imparted through the Internal Quality Assurance Cell (IQAC) of the Mentor Institutions, which shall be primarily responsible for the implementation of the programme.
- The IQAC creates a Standing Committee where expertise can be pooled from multiple sources. The Committee shall work under the stewardship of an Accreditation Ambassador (AA) who could be provided a fellowship on the lines of Emeritus Fellowship.

- The IQAC is expected to identify the participating institutions (Mentee) for mentoring them to get accreditation.
- The participating institutions are required to nominate fulltime faculty members (one from each participating institutions) as the Coordinator of the project.
- A detailed framework for the proposed accreditation mentorship along with targets and timelines shall be prepared.
- An implementation plan should be developed with clear timeline and schedule for monitoring of progress.
- Execution of the implementation plan may include various activities like mentor-mentee meetings, developing strategies, defining goals and deliverables.
- A manual to guide the institution to prepare for accreditation may be developed.
- The mentee Institutions may undergo the complete Accreditation process with the help of Mentor institution in order to prepare them for the actual NAAC assessment process.

#### **Article 5 : DURATION**

Duration of the MoU shall be of one year which may be extended up to one more year.

#### **Article 6: COORDINATION**

The Mentor Institution through its IQAC shall identify the potential areas of improvement in assessment criteria i.e. Curricular Aspects, Teaching Learning & Evaluation, Research, Innovation & Extension, Best Practices so on and so forth. Further the mentor institution can guide the mentee institution to focus and guide their application procedure at different stages.

The Mentee Institution through its IQAC may undergo the complete Accreditation process with the help of the Mentor Institution in order to prepare themselves for the actual NAAC Assessment process.

The IQAC creates a Standing Committee where expertise can be pooled from multiple sources. The Committee shall work under the stewardship of an Accreditation Ambassador (AA) who could be provided a fellowship on the lines of Emeritus Fellowship.

## Article 7 : TERMINATION

Either institution may terminate the MoU by giving written notice of six months in advance to other institution. Once terminated, neither SAC nor MAC will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, SAC and MAC will ensure that the provisions of this progress until their completion.

## Article 8 : AMENDMENTS

The MoU may be amended or modified by a written agreement signed by the representatives of both institutions.

## Article 9 : LEGAL EFFECT


Nothing in this MoU shall be construed as creating any legal relationship between the institutions. This MoU is a statement of intent to foster genuine and mutually beneficial collaboration.

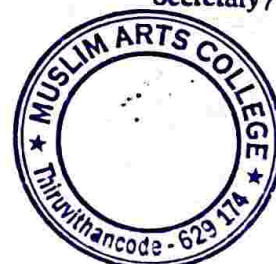


